ARTICLES OF INCORPORATION

OF

Site Financial Services, Inc.



ARTICLE I: NAME

The name of this corporation is Site Financial Services, Inc. whose address, 800 NE 6th Terrace, Boca Raton, Florida 33486.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE


