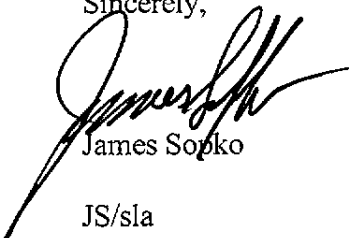

ARTICLE I

NAME

The name of this corporation shall be: SHEETAL KUMAR, M.D., P.A.

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE IV

CAPITAL STOCK

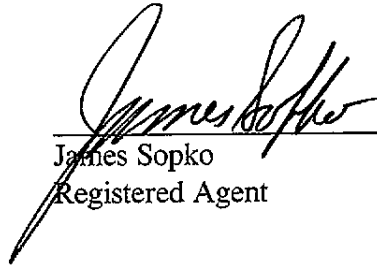
