ARTICLE III. CAPITAL STOCK

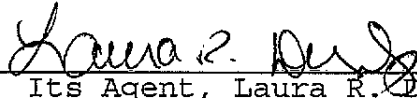

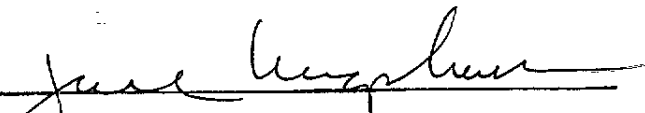
