ARTICLES OF INCORPORATION OF LIFETIME HOMES OF JACKSONVILLE, INC.

The undersigned incorporator, desiring to form a corporation in the State of Florida, in accordance with the Florida Business Corporation Act, adopts the following Articles of Incorporation for the corporation:

ARTICLE I

NAME

The name of the corporation is Lifetime Homes of Jacksonville, Inc.

ARTICLE II

PRINCIPAL OFFICE AND INTIAL REGISTERED AGENT

The address of the corporation's principal office is 9301 Old Kings Road, Jacksonville, Florida 32257. The name of the initial registered agent of the corporation, located at that office is Rene' Dostie, Jr.

ARTICLE III

DURATION

The period of the corporation's duration shall be perpetual until dissolved on a vote of the shareholders as provided in these Articles.

ARTICLE IV

PURPOSE

This corporation is organized for the following purpose:

To engage in any lawful business permitted by the State of Florida

ARTICLE V

CAPTIAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is 1000 shares. These shares shall be of a single class of common stock, and shall have no par value.

CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

DIRECTORS

Following the adoption of Bylaws by affirmative vote of three-fourths of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with the Bylaws.

ARTICLE X

DISSOLUTION

The corporation may be dissolved at any time by the affirmative vote of the holders of at least three-fourths of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shar5eholder.
