ARTICLES OF INCORPORATION FOR

CUSTOM COUNTERTOPS, INC.

Article I.

Corporate Name

The name of this corporation is CUSTOM COUNTERTOPS, INC.

Article II.

Nature of Business and Powers

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of One Dollar (\$1.00) per share.

Term of Existence

This Corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

Pre-Emptive Rights
