ARTICLES OF INCORPORATION

OF

BDC BONNET CREEK, INC.

The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation of such corporation.

ARTICLE I  
NAME

The name of this corporation is BDC BONNET CREEK, INC.

ARTICLE II  
DURATION

This corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually unless dissolved by operation of law.
