ARTICLES OF INCORPORATION

OF

SearchX, Inc

ARTICLE I

The name of this corporation shall be:

Search, Inc.

ARTICLE II

This corporation shall have perpetual existence unless dissolved according to law.

ARTICLE III

PURPOSE. The general nature and purpose of the corporation and the purposes proposed to be transacted, promoted and carried out are as follows:

- A. Transacting any or all lawful business for which corporations may be incorporated under Florida Statute.
- B. To engage in business of providing services to businesses doing business on the Internet, users of the Internet, sales and service, telecommunications, but not limited to providing long distance service and pre-paid calling cards.
- C. To invest the funds of this corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the accomplishment of the corporation purposes.
- D. To do all and everything necessary and proper for the accomplishment of any of the

purposes or the attaining of any of the objectives or the furthermore of any of the purposes numerated in these Articles of Incorporation or any amendment hereof necessary and incidental to protection and benefit of the corporation, and in general, either alone or in association with other corporations, firms, or individuals to carry on any lawful manner, pursuit necessary or incidental to the accomplishment of the purposes or objects of this corporation.

E. The forgoing paragraphs shall be construed as enumerating both objects and purposes of this corporation and it is hereby expressly provided that the forgoing enumeration of specific purposes shall be held to limit or restrict in any manner of this corporation otherwise permitted by law.

ARTICLE IV

The principal place of business and mailing address of this corporation shall be 3544 Gatlin Place Circle, Orlando, Florida 32812.

ARTICLE V

CAPITAL STOCK The corporation is authorized to issue 50,000,000 shares of capital stock at a par value of \$.001 per share. The 50,000,000 shares of capital stock at a par value of \$.001 per share are to be designated as COMMON SHARES.




