The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article I

NAME

The name of the corporation is LOOK & BOOK, INC. and the principal address shall be \$277 Collins Avenue, Penthouse 5, Surfside, Florida 33154

DURATION

The corporation shall exist perpetually. Corporate existence shall commence upon filing by the Department of the State.

- (a) Authorized Capital.
