ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article I

NAME

The name of the corporation is LOOK & BOOK, INC. and the principal address shall be 8877 Collins Avenue, Penthouse 5, Surfside, Florida 33154

Article II

DURATION

The corporation shall exist perpetually. Corporate existence shall commence upon filing by the Department of the State.

Article III

NATURE OF BUSINESS

CAPITAL STOCK

(a) Authorized Capital. 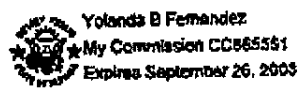


