ARTICLES OF INCORPORATION

FOR

Brantley Educational Services, Inc.

ARTICLE I - NAME

The name of this Corporation shall be **Brantley Educational Services, Inc.**

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon the acceptance of these articles.

ARTICLE III - PURPOSE
