ARTICLE V: INCORPORATOR

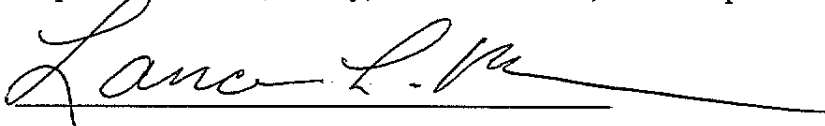

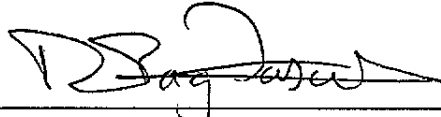
