

I. NAME

The name of the corporation is GARY BOWLES APPRAISAL SERVICES, INC.

II. TERM OF EXISTENCE

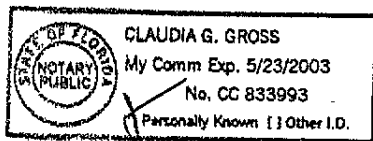





