ARTICLES OF INCORPORATION

I, the undersigned subscriber to these Articles of Incorporation, being a person Competent to contract, hereby associate myself for the purpose of becoming a corporation under the law of the State of Florida providing for the formation, liability, rights, privileges, and immunities of corporations for profit.

ARTICLE I – NAME

The name of this corporation shall be CAFE CON LECHE BAKERY & CAFETERIA, INC.

ARTICLE II – NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III – CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is Three Hundred (300) shares of common stock, of \$1.00 Par value. The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE IV – INITIAL CAPITAL

This Corporation may be a Sub-Chapter S Corporation as defined by the Internal Revenue Code.



ARTICLE XII- REGISTERED AGENT


