ARTICLE I

The name of this corporation is LINDA PULEO, INC.

ARTICLE II

This corporation is organized for the purpose of engaging in and transacting any lawful business permitted under the laws of the United States and the State of Florida. The principle business activity of this corporation is Real Estate Services.

ARTICLE III

The term for which this corporation shall exist shall be perpetual.

ARTICLE IV

The amount of capital stock authorized by these Articles of Incorporation, being the maximum shares of capital stock which the corporation is authorized to issue and have outstanding at any time shall be 1000 shares of common stock at \$1.00 par value. Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1986, as amended.

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued..


