

The undersigned incorporator hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE. 1 NAME

The name of the corporation shall be **TRUVILLA CORP.** and the address of the principal office of the corporation shall be 27 Pennock Lane #205, Jupiter, Florida 33458, and the mailing address shall be the same.

ARTICLE 2. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE 3. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 50 shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE 4. REGISTERED AGENT

The initial registered agent of the corporation is Arthur W. Trufelli and his address is 5253 Center Street, Jupiter, Florida 33458.

ARTICLE 5. TERM OF EXISTENCE




