OO HE OF SOME The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I **NAME**

The name of the corporation shall be; CONTINENTAL PARALEGAL SERVICES INC.

ARTICLE II NATURE OF BUSINESS

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
