### ARTICLES OF INCORPORATION BCJ INVESTMENT GROUP, INC. a Florida Corporation

OF EBYSE MON The undersigned, acting as Incorporator of a Florida corporation ("Corporation"), under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the

#### ARTICLE I NAME

following Articles of Incorporation for such Corporation:

The name of the Corporation is BCJ INVESTMENT GROUP, INC.
