**ARTICLES OF INCORPORATION
OF**

L.C. FURNEY & ASSOCIATES, INC.

The undersigned incorporator of these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation pursuant to the laws of the State of Florida and does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of the Corporation is L.C. FURNEY & ASSOCIATES, INC. and the mailing address of the Corporation is 214 Woodland Court, Safety Harbor, Florida 34695.

ARTICLE II - DURATION

This Corporation is to exist perpetually.

ARTICLE III - GENERAL PURPOSES

The general purposes for which this Corporation is formed are to provide consultant services to the heavy construction industry, and to transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
