# ARTICLES OF INCORPORATION OF NHP AFFORDABLE HOUSING CORPORATIONGOLDEN PARK SENIOR APARTMENTS

The undersigned incorporator hereby forms a corporation under Chapter 607 of laws of the State of Florida.

#### ARTICLE I. NAME

The name of this Corporation shall be as follows: NHP Affordable Housing Corporation- Golden Park Senior Apartments

#### ARTICLE II. ADDRESS

# ARTICLE III. NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or jurisdiction.

# ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this Corporation shall be authorized to have outstanding at any one time is 1,000 shares of common stock, par value \$.01 per share.
