ARTICLES OF INCORPORATION OF MISS IRENE'S CHILDREN LEARNING CENTER, INCORPORATED

The undersigned subscriber to these articles, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, and under the following articles:

ARTICLE I. NAME

In the event the corporation is legally unable to purchase such stock or otherwise waive its privilege of purchasing, the secretary of the corporation shall mail written notice to all remaining stockholders, by certified mail, return receipt requested, advising them of the terms of such bona fide offer, and unless the terms of such offer are accepted by any or all of the other stockholders within ten (10) days, from the date of mailing such notice, they shall be deemed to have waived their

privilege of purchasing and the stockholders, or the person in privity with him, desiring to sell shall be at liberty to effect a sale upon the terms of such bona fide offer. No stockholder may cause the corporation or the remaining stockholders to waive their privilege of purchasing until such stockholders has received a bona fide offer for the purchase of such shares.
