ARTICLES OF INCORPORATION OF

JOEL L. COHEN, D.O., P.A.

The undersigned, for purposes of forming a business corporation under the provisions of Florida Statutes Chapter 607, the Florida Business Corporation Act, and Florida Statutes Chapter 621, the Professional Service Corporation and Limited Liability Act, adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be IOEL L. COHEN, D.O., P.A. (hereinafter call the "Corporation").

ARTICLE II PRINCIPAL ADDRESS

The address of the principal office and the mailing address of the office of the Corporation is 11151 Nautilus Drive, Cooper City, FL 33026.

ARTICLE III PURPOSE

The general purpose for which the Corporation is organized is to engage in every aspect of the practice of medicine. The professional services involved in the Corporation's practice of medicine may be rendered only through its officers, agents and employees who are fully authorized and licensed to practice medicine in the State of Florida.

The Corporation shall not engage in any business other than the practice of medicine. However, the corporation may invest its funds in real estate, mortgages, stocks, bonds and other types of investments, and may own real estate and personal property for the rendering of the professional services authorized hereby.

<u>ARTICLE IV</u> CAPITAL STOCK

The capital stock authorized shall be 1,000 shares, such shares shall be of a single class, and shall have a par value of \$0.01 per share.

The Corporation shall only issue its common stock to an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the Corporation was incorporated. Shareholders of this Corporation shall not enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his/her stock.
