## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF STUDIO OP'S, INC.

The undersigned, Hugh E. Darley, Jr., President of STUDIO OP'S, INC., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:
