**ARTICLES OF INCORPORATION
OF
THE THOMASSON CANDY CORPORATION**

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is: The Thomasson Candy Corporation.

SECOND: The street address, wherever located, of the principal office of the corporation is: 330 Wellington Drive, Palm Coast, Florida 32164.

The mailing address, wherever located, of the corporation is: 330 Wellington Drive, Palm Coast, Florida 32164.

THIRD: The number of shares that the corporation is authorized to issue is One Thousand (1,000), all of which are of a par value of one cent (\$0.01) each and are of the same class and are Common shares.

FOURTH: The street address of the initial registered office of the corporation in the State of Florida is 330 Wellington Drive, Palm Coast, Florida 32164.

The name of the initial registered agent of the corporation at the said registered office is William H. Thomasson.

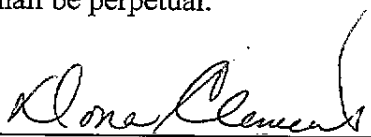
FIFTH: The name and the address of the incorporator are Dona Clement, 301 Grant Street, 20th Floor, Pittsburgh, PA 15219.
