The name and address of the person signing these Articles is Stephen R. Williams, 5100 North Creek Drive, Wilmington, North Carolina 28409.

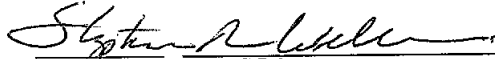
ARTICLE VIII - BYLAWS

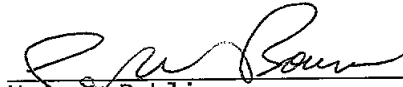
