ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I: NAME

obtaining prior shareholder approval of any and each such transaction by the vote or written consent of

the holders of 51% of the shares of the corporation entitled to vote thereon and not otherwise.

ARTICLE XIII: INFORMAL ACTION OF DIRECTORS

If all the directors severally or collectively consent in writing to any action taken or to

be taken by the corporation, and the writings evidencing their consent are filed with the secretary of the

corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of

Directors.
