

ARTICLES OF INCORPORATION



OF

RA-ZEN RELIEF, INC.

This Corporation, pursuant to the provisions of Sec. 607.1007, Florida Statutes, does hereby adopt these RESTATED ARTICLES OF INCORPORATION, as follows:

ARTICLE I - NAME

The name of the Corporation is:

ARTICLE IV – CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is 50,000,000 shares of Common Stock which shall have a par value of \$0.10 per share. Shareholders shall have no preemptive rights. Cumulative voting shall not be permitted. The Corporation shall not be governed by FLA STAT. ch. 607.0902. Shares of Common Stock may be issued at such time or for such consideration as the Board of Directors may determine.
