As a result of our conversation today, I am enclosing an invoice to Red Rhino Heat Exchangers, Inc. for professional time rendered on behalf of your corporation. Because you terminated our services prior to completion of your corporate returns, you will not be receiving tax returns from our office. Our records indicate that all your original records have been returned to you.

I believe we can substantiate significant labor on our part. I also believe we can substantiate significant delays on your part in providing us with the information we requested.

As a courtesy, we have provided a credit for items currently in dispute. We do not waive any right to collect our customary fees in full. It is our position that the timely filing of a uniform business report is the responsibility of the corporate officers, and is outside of the normal scope of income tax return preparation.

Our efforts to pursue this claim for unpaid fees will be largely dependent upon your willingness to resolve our differences without further escalation.
