ARTICLE I. NAME OF CORPORATION


**ARTICLE VII.

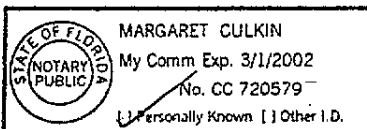


