The coporation shall be governed by bylaws adopted by the shareholders.

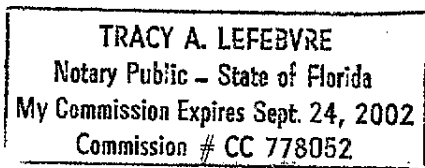
