ARTICLES OF INCORPORATION  
OF  
DELBERT L. TOWNS INSURANCE AGENCY, INC.

ARTICLE I – NAME

The name of this corporation is DELBERT L. TOWNS INSURANCE AGENCY, INC.  
The address of this corporation is 3525 MURRELL ROAD, ROCKLEDGE, FLORIDA 32955.

ARTICLE II – DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be APRIL 1, 2000.

ARTICLE III – PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV – CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$5.00 par value common stock.

ARTICLE V – PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which is already held, shall have the right to purchase their pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
