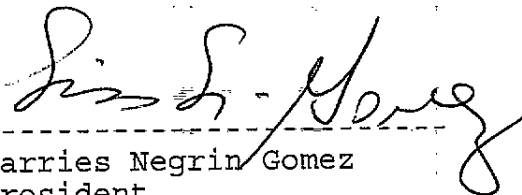

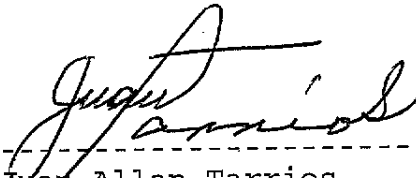
This corporation shall have three (3) directors initially. The number of directors may be increased or demised from time to time by the by-laws adopted by the stockholders.

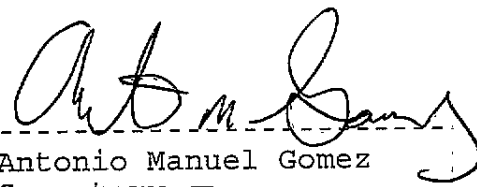
