FOURTH: The street address of the initial principal office of the corporation is 10693 Wiles Road, PMB 230, Coral Springs, Florida 33076.

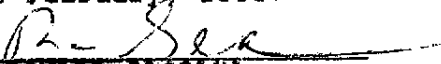
