**ARTICLES OF INCORPORATION  
OF  
TULLYRUSK, INC.**

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the Florida Business Corporation Act.

**ARTICLE ONE  
Corporate Name**

The name of the Corporation is **TULLYRUSK, INC.**

**ARTICLE TWO  
Duration**

The duration of the Corporation shall be perpetual.

**ARTICLE THREE  
Purpose**

The purpose for which the Corporation is initially organized includes the transaction of any or all lawful business for which corporations may be incorporated under Florida law including but not limited to acquisition of collectibles such as prints, paintings, tapestries, antiques and like items of value and interest.

**ARTICLE FOUR  
Capital Stock**

The aggregate number of shares which the Corporation has authority to issue is **ONE THOUSAND (1,000)** shares of common stock having a par value of **\$2.00** each.

**ARTICLE FIVE  
Preemptive Rights**

Each Stockholder of the Corporation shall have the right to purchase, subscribe for, or receive a right to purchase at the par value thereof, a pro rata portion of any Stock of any class that the Corporation may issue or sell, whether or not exchangeable for any Stock of the Corporation of any class or classes, and whether or not of unissued shares authorized by the Articles of Incorporation as originally filed or by any amendment thereof or out of shares of Stock of the Corporation acquired by it after the issuance thereof, and whether issued for cash, labor done, personal property, or real property or leases thereof.

### **ARTICLE ELEVEN Amendment**

These Articles of Incorporation may be amended by resolution adopted by the Board of Directors and presented to and approved at a meeting of shareholders by the holders of a majority of the outstanding shares entitled to vote, or may be amended by all of the Directors and all of

the shareholders signing a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

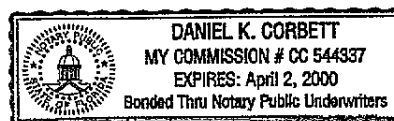
