Per our conversation there were several attempts to fill the annual report, but somehow it was incorrect. However the documents were returned between May 23rd and June 26th for correction, during this time I was away on business and the person that I had done this for me did not have access to my mail, so there were no correction made in a timely fashion. Only until I returned on October 11th the documents were filled out correctly with the registered agent signature; In fact I spoke to an agent from your office on that same day and he asked me to write a letter, which I did on October 18th explaining why the document wasn't resubmitted in a timely matter. Your agent said to write this letter and not to worry about being reinstated.

When I did not receive my 2002 application I called your department and your agent informed me that the company was dissolved due to annual report filing.
