ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be Size8 Software, Inc

ARTICLE II - PRINCIPAL OFFICE

The principal office of business and mailing corporation shall be:

ARTICLE III - SHARES

- (1) This corporation is authorized to issue only one class of stock; and the number of shares of stock that this corporation is authorized to have outstanding at any one time is 750.
- (2) All of the corporation's stock, exclusive of treasury shares, shall be held of record by not more than seventy-five (75) persons.
- (3) Each shareholder shall offer to the corporation or the other shareholders of the corporation a thirty (30) day "first refusal" option to purchase the stock of the shareholder electing to sell stock in the corporation.
- (4) No shareholder may transfer stock to an ineligible shareholder (i.e. those ineligible to hold stock in an S corporation) without the consent of the other shareholders.
