BANKERS FIDELITY MORTGAGE CORP.

ARTICLE I - Name

The name of the corporation shall be: BANKERS FIDELITY MORTGAGE CORP.

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.
