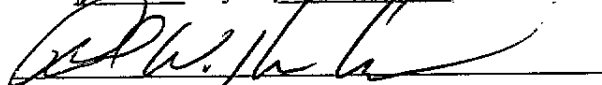
The corporation is a statutory close corporation.

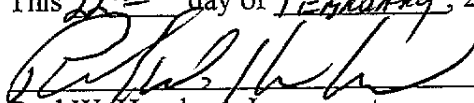
