### **ARTICLE I                      NAME**

The name of the corporation shall be: **Greg Collinsworth Investment Management, Inc.**

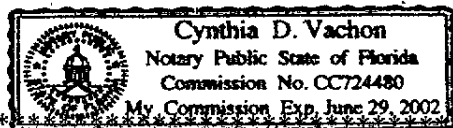
