

ARTICLE I. NAME

The name of this corporation is LEONEL COBAS ENTERPRISES, INC.

ARTICLE II. ADDRESS

The principal place of business and mailing address of this corporation shall be 3009 Cypress Gardens Road, Winter Haven, Fl. 33884.

ARTICLE III. DURATION

This corporation shall exist perpetually. Corporate existence shall commence with the filing of these articles with the Department of State.

ARTICLE IV. PURPOSE



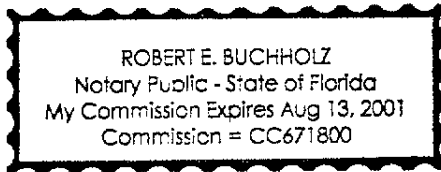
