The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract and an Attorney at Law duly licensed to render services as such under the laws of the State of Florida, hereby presents these Articles for the formation of a corporation under the Professional Services Corporation Act, and other laws of the State Of Florida.
