**ARTICLES OF INCORPORATION**

ARTICLE I - NAME

The name of this corporation is FROM THE TOWER, INC.

ARTICLE II - PRINCIPAL OFFICE

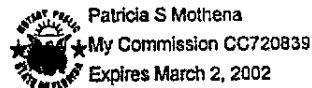
