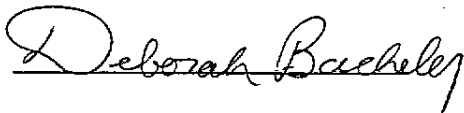

ARTICLE XI = AMENDMENT

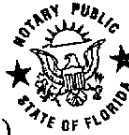
