ARTICLE I.

The name of the corporation shall be **SQUARE L CORP.**

ARTICLE II.

The principal place of business of the SQUARE L CORP. shall be located at 1614 Ohio Avenue, Lynn Haven (Bay County), Florida 32444. **The MAILING ADDRESS for SQUARE L CORP. Is Post Office Box 1380, Lynn Haven, Florida 32444.**

ARTICLE III.

The general nature of this business and the objects and purposes to be transacted and carried on are:

To do any and all of the things herein mentioned as fully and to the same extent as natural persons might or could do, to-wit:

To take, acquire, buy, hold own, maintain, work, develop, sell, convey, lease, mortgage, exchange, and improve, and otherwise deal in and dispose of real estate and real property and all other kinds of property of any nature whatsoever, whether real, personal or mixed, or any interest or rights therein without limits as to amounts; to buy and sell, convey, assign and cancel liens upon personal property and real estate of every kind, class or nature; to draw, acquire, enforce, discount and deliver bills of exchange, promissory notes, bonds debentures and other negotiable instruments of any kind, class, or nature, and secure the same by mortgage on its property or otherwise; to issue on commission, subscribe for, take acquire, hold exchange and dealing shares, stocks, bonds, obligations, or securities of any government, or authority, individual or corporation.

Generally, to make and perform contracts of any kind or description, and for the purpose of attaining any of the objects of the corporation, to do and perform any other acts or things to exercise any and all powers which a partnership or natural person cold do and exercise, and which now or thereafter may be authorized by law, and generally to do and perform all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied.

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is three (3) shares of common stock with a nominal or par value of TEN and NO/100 (\$10.00) DOLLARS, per share.
