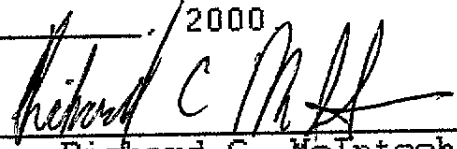
in these articles of incorporation, or any amendment thereto, and any such right so conferred upon the shareholders is subject to this restriction.
