ARTICLE I.

NAME

The name of this corporation is Ristorante da Tullio, Inc.

ARTICLE II.

PRINCIPAL OFFICE

CAPITAL STOCK

This corporation shall have four (4) directors initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1). ARTICLE VIII.

INCORPORATOR

ARTICLE IX.

AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

BYLAWS


