ARTICLE I – NAME

The registered agent shall be Khalid M. Ansari at 15300 SW 40<sup>th</sup> Court Miramar, Fl 33027

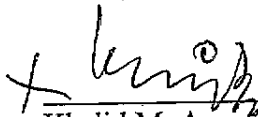
ARTICLE VI – BOARD OF DIRECTORS

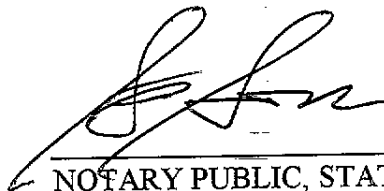

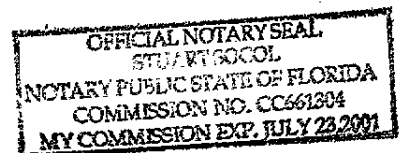
