ARTICLES OF INCORPORATION

OF

TS&C Trucking, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE - NAME AND ADDRESS

The name of the corporation shall be TS&C Trucking, Inc. The principal place of business of this corporation shall be 3929 Hernden Drive, Lake Worth, FL 33460.

ARTICLE TWO - DURATION

The term of the corporation's existence is perpetual.

ARTICLE THREE - PURPOSE
