# ARTICLES OF INCORPORATION

**WE, THE UNDERSIGNED**, hereby certify that we have associated ourselves together for the purpose of establishing a corporation under and in accordance with the provision of Chapter 607 Florida Statutes, providing for the Information, rights and privileges and immunities of the corporation for profit and in pursuance of the terms of said Statutes, we hereby declare and certify as follows:

## ARTICLE I - NAME

The name of this corporation shall be **MATTHEW S. MUDANO, P.A.**. The mailing address of the corporation shall be: **10709 Carroll Lake Drive, Tampa, FL 33618.**

## ARTICLE II - DURATION

This corporation shall exist in perpetuity.

## ARTICLE III - PURPOSE

This Corporation is organized for the following purposes:

(a) To engage in every aspect of the practice of law and all of its fields of specialization as are engaged in by lawyers in this state.

(b) To engage and render the professional service involved only through its officers, agents, and employees who are lawyers in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the professional service of this Corporation.

## ARTICLE XIII - SPECIAL PROVISIONS

It is the Intent of the incorporators that the corporation will qualify under Section 1244 of the Internal Revenue Code and that the corporation will file as a Subchapter "S" corporation.

## ARTICLE XIV - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to reservation.

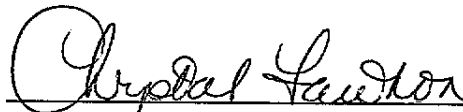
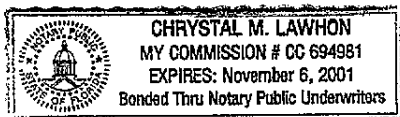
