The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I. NAME**

The name of this corporation shall be **Dawson Sales, Inc.**

**Article II. NATURE OF BUSINESS**
