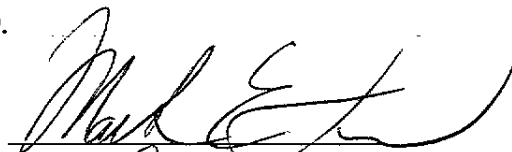
ARTICLE TEN

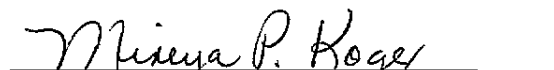

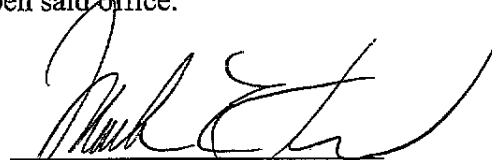
